**Adjourn:**

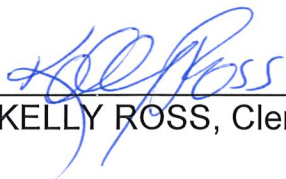
Michael moved to adjourn the meeting at 6:15 p.m. Flora seconded the motion, all were in favor, motion carried.
